Letter to Our Donors

Because of the generosity of many corporations and individuals such as you, the Highline Community College Foundation had its most successful fundraising year in history, receiving just over \$385,000 in contributions. We thank you for your generosity and support.

This past year with your assistance the Foundation was able to increase the amount for scholarships to \$55,000 and also distributed over \$21,000 in emergency assistance.
