## Letter to Our Donors

Thank you to those of you who have supported the Foundation at Highline Community College over the past year. Many of you are listed in this report, but we have had to limit the list of donors to those who gave a minimum of \$100 or more because of space and budget restraints. All gifts are deeply appreciated no matter the size, and they make a difference in the lives of Highline's students.

For the fourth year in a row, your donations have set a new record. The Foundation took in \$395,000 this year. Because of your generosity, \$83,000 in scholarships was awarded to 45 different students for the 2003-2004 academic year.
